



Anglian Pass Application Form (01 April 2024 to 31 March 2025)

The Anglian Pass allows unrestricted visitor access to the navigations of the Environment Agency, the Middle Level Commissioners and Conservators of the River Cam for one year starting the 01 April to the following 31 March. The Anglian Pass is only available for powered boats that have a valid annual vessel registration/licence with the Environment Agency (including a Gold Licence obtained through the Canal & River Trust), Middle Level Commissioners or Conservators of the River Cam based on your home/permanent mooring.

You must ensure you have a valid annual vessel registration/licence for the term of the Pass, or your Pass may be revoked, and your vessel will therefore be considered unregistered. For example, Gold Licence holders must renew their annual registration in January for the Pass to be valid to the end of March.

Anglian Pass charges for this season are:

Vessel up to 5 metres in length	£30.00
Vessel over 5 metres to 10 metres (inclusive) in length	£60.00
Vessel over 10 metres to 15 metres (inclusive) in length	£90.00
Vessel over 15 metres in length	£120.00

5. Conditions, declarations and signatures

Conditions of Anglian Pass Registration for powered vessels include:

- 1) Evidence of a valid home navigation annual registration/licence will be required to register for an Anglian Pass. An Anglian Pass without a valid home registration/licence will be deemed invalid.
- 2) You must ensure you have a valid annual vessel registration/licence for the term of the Pass, or your Pass may be revoked. For example, Gold Licence holders must renew their annual registration in January for the Pass to be valid to the end of March.
- 3) The Anglian Pass must be clearly displayed on both sides of the vessel at all times. If the Anglian Pass is not displayed, the vessel may be deemed to be without an appropriate registration/licence.
- 4) The Anglian Pass is considered a Visitor Licence and may not be used to moor permanently on a partner navigation other than that which provided the full annual licence.
- 5) Any inaccuracies in the information provided on the application form may render any Anglian Pass Registration purchased, invalid.
- 6) The Partner navigation authorities require all boat users to follow their respective Byelaws whilst on their waterways. The requirement to hold a valid registration/licence to allow the use of their respective waterways is applicable to all partner waterways.
- 7) Navigation Authorities may take Enforcement Action in relation to unregistered vessels on any partner waterways.
